2023 GRANTS

Since 1992, the Disabled American Veterans of Minnesota Foundation has operated as the organization's "giving arm." Separate from DAV of Minnesota, the Foundation is run by a Board of Directors who manage the funding of programs and services for DAV of Minnesota, as well as other organizations across the state. This year, the DAV of Minnesota Foundation contributed over \$527,000 to programs and services, community grants and projects. The Foundation continues to lean forward to support the everchanging needs of Minnesota Veterans and their families.

The DAV of Minnesota Foundation supports ongoing partnerships with other Minnesota non-profit organizations that support DAV of Minnesota's mission. In 2023, grants included:

- \$30,000 to support the Center for Development and Civic Engagement and Recreation/Creative Arts Departments at the VA Medical Centers.
- \$74,000 towards programs that combat Veteran homelessness and food insecurity.
- \$105,000 towards transportation programs at the DAV of Minnesota Department and chapters.

Disabled Veterans need to be able to live independently, with dignity and a sense of normalcy. In 2023, more than half of the grant money awarded by the Foundation went to programs helping veterans to do just that. They included:

- \$54,000 towards Adaptive Sports programs that promote sports therapy and rehabilitation for Veterans with traumatic brain injuries, spinal cord injuries, orthopedic amputations, visual impairments and certain neurological conditions. Often, these experiences provide the catalyst which improves overall physical well-being, mental health, self-esteem, and the ability to re-enter and adjust to community
- \$219,000 to make the outdoors accessible to all Veterans. Specifically, this went towards the DAV of Minnesota Outdoor programs at the Department and Chapter levels and Wilderness Inquiry. Wilderness Inquiry provided trips to the Boundary Waters Canoe Area, Apostle Islands and Olympic National Park. These adventures inspired personal growth, enhanced awareness of the environment and encouraged veterans to open themselves to new possibilities and opportunities.

Other grants supported several initiatives to combat Veteran Homelessness and support programs for Women Veterans.

When we wore the uniform, we got through hard times because we had our brothers and sisters in arms. Now that we are Veterans. the same concept applies. Healing happens in nature surrounded by those facing the same struggles.

The 18th Annual Minnesota DAV Golf Classic, held July 25, 2023, at Crystal Lake Golf Course, was a success. Funds raised from the event helped purchase two new vehicles enabling the Transportation Program to better serve veterans in their communities throughout the State.

Wilderness Inquiry Guided Trips + A Focus on Women and Families

2023 was the DAV of MN Foundation's second year of partnership with Wilderness Inquiry. Since its inception, this partnership has allowed Veterans and their families to experience the health and wellness benefits the outdoors provides. This year, the Foundation made a concerted effort to provide these same health and wellness benefits to Women Veterans and families, encouraging independence and enhancing the quality of life. The Foundation granted \$51,000 to fulfill this goal, funding two trips for Veterans and their families as well as a first-ever trip for women veterans only.
